MEMORANDUM OF UNDERSTANDING

This Memorandum of understanding (herein after called as the Mou) is entered for a period of 2 year from the date of Signature by and between.

Chaman Lal principal (herein after referred as first party the institution which expression unless excluded by or repugnant to the subject or context shall include it's successors in office administrators and assigns.)

AND

Tapan Rehabilitation Society, Pragya Institute for Education and Training of Differently Abled, G.T. Road, Near Police Post, Nilokheri and represented here in by its Centre head Dr. Sujata here in after referred as shall include in successor in office administrators and assign.

(First party and Second party are here in after jointly referred to as parties and individually as Party as.

WHEREAS:

A) First party is placement and internship cell of a higher education institution named SGTBJ Government College Taraori Karnal

B) First party and second party believe that collaboration and co- operation between themselves will promote more effective use of each of their resources and provided each of them with enhanced opportunities.

C) The parties intent to cooperate and focus their efforts on cooperation within area of skill base training education and placements.

D) Both parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interests.

E) Tapan rehabilitation society, pragya Institute for education and training of Differently abled the second party is one of the five centres of excellence

established by the department of Higher Education order to import training disseminate knowledge in order to promote freelancing in entrepreneurship and employability of student graduate final year student of college and Universities.

F) Tapan Rehabilitation society, Pragya Institute for education and training of Differently Abled is a centre of Excellence established in PT CLS government college Karnal is one of the five centre of excellence established by the department of fire education government of Haryana.

Now therefore is consideration of the mutual promises set 4th in this MOU the part is here to agree as follows.

CLAUSE-1

Co- operation

- 1.1 Both the party shall work together to attend the common goals and objective which is to train maximum of student through different programs and Technologies which are being offered by the second party
- 1.2 First party shall corporate entrance of outrage for student current batch and to previous year pass out of Government College of girls padhana Karnal campus in order to benefit to student with free training and subsequent placement opportunities.
- 1.3 First party shall provide all the infrastructure required for training like computers, Classrooms, Tables, Chairs, Printer, Stationery, Projector Washroom, etc to second party.
- 1.4 First party Shall appoint a coordinator to cooperate in day- to- day activities and training so that smooth working of project shall ensured.
- 1.5 First party Shall share the details of the students which are being targeted course/program wise in order to maximize the conversation from the students.

- 1.6 The common goal is to train & place maximum students in the industry either from the current batch studying in the premises of first party or the past out of previous 2 years.
- 1.7 Second party will co-operate in terms of arrange special sessions, classes, new programs & curriculum (as required, time to time) soft skill session etc for the students.
- 1.8 Second party bound to work as per directives from Department of Higher Education and it will continue to work in such manner.
- 1.9 Both parties are United by common interest and objectives and the cell established channels of communication and cooperation that will promote and advance dear respective operations within the Institution and its related wings. The parties shall keep Each Other informed of potential opportunities and cell all information that may be reliable to secure additional opportunities for one another.
- 1.10 The general terms of co-operation Shall by governed by this MOU . The parties shall corporate with each other and shall as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the definitive documents) as may be required to give effect to the action contemplated in terms of this MOU. The terms of definitive documents shall be mutually decided between the parties. Along with the Definitive Documents this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the parties on the subject matter hereof.

CLAUSE- 2

SCOPE OF THE MOU

2.1 The budding graduates from the Institutions could play key role in technological upgradation, Innovation and competitiveness of an industry. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.

2.2 Curriculum design: Second party has developed the Curriculum as per the industry standards for various programs. First party shall be free to give valuable input to the second party in teaching/ training methodology and suitable customize the curriculum so that the students fit into the industrial scenario meaningfully.

2.3 Placement Interviews/Drive:-Once students are Trained and certified by the Second party they shall be ready to work in the industry and both the parties must come together in order to place them across the industry. The goal is to place maximum students. Second party is working on the objective of promoting Freelance , Entrepreneurship & Employability skill.

First party shall make its efforts to place the trained students across their existing industry associations and Second party shall do the same.

Upon selection in a company, the first party Shall have to share the details such as:-

- A. Offer letter/Letter of intent.
- B. Details of student placed.
- C. Any other details pertaining to their employment as a disclosure.

2.4 Skill development programs:

Second party to train the students of first party on the emerging technologies in order to bridge the skill gap and make them industry ready.

2.5 guest lecturers:

Second party to extend the necessary support to deliver guest lectures to the Students of the first party on the technology trends and in house requirements.

2.6 there is no financial commitment or exchange on the part of any of the parties i.e., placement and internship cell, government college for girls, padha(karnal)(first party)and eKarma-- karnal centre (second party).

CLAUSE 3

INTELLECTUAL PROPERTY

3.1 Nothing contained in this MOU shall, by express grant, implications, Estoppel or otherwise, create in either party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, invention, patents, copy rights and design) of the other party.

CLAUSE 4

VALIDITY

4.1 This agreement will be valid until it is expressly terminated by either party on mutually agreed terms, during which period eKarma--Karnal centre (A Unit of Appworx IT solutions Pvt. Ltd.), the second party, as the case may be, will take effective steps for implementation of this MOU. Any act on the part of eKarma--Karnal centre (A Unit of Appworx IT solutions Pvt.Ltd.), the second party after termination of this agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU

4.2 Both parties may terminate this MOU upon 30 calendar days notice in writing. IN the event of termination, both parties have to discharge their obligations.

CLAUSE 5

RELATIONSHIP BETWEEN THE PARTIES

5.1 It is expressly agreed that SGTBJ Govt. College, Taraori (Karnal) and Appworx IT solution Pvt Ltd (Local training centre: Government college Karnal are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither party is authorized to use the other party's name in any way to make any representations or create any obligation or liability, expressed or implied, on behalf of the other party, without the prior written consent of the other party. Neither party shall represent itself as holding any authority under this
