



NOTIFICATION

The University has decided to conduct the practical examinations of 6th Semester onwards Under-Graduate/ Certificate/ Diploma/ Advance Diploma Courses (Traditional/Professional)/ 5 year integrated courses, being run in all UTDs/ Institutes/ Colleges (under NEP/Non-NEP) for Fresh/ Re-appear students for the session April/May-2026 w.e.f. 15.04.2026 to 05.05.2026.

Further, as notified by this office vide Endst. No. CT-III/25/9657-9816 Dated 18.11.2025, practical examinations in SEC/MDC/AEC/VAC and Vocational/Pool Courses shall be conducted internally by all the Departments/Institutes/Colleges (Govt./Govt. Aided/SFS). However, the practical examinations in Major/Minor subjects shall be conducted internally by all UTDs/Govt./Govt. Aided Colleges. In respect of SFS Institutes/Colleges, the existing practice of conducting the said Practical Examinations externally through the appointment of External Examiners shall continue to remain in force.

The panel for all Practical subjects will be supplied to all SFS Institutes/ Colleges only by the University at the earliest. The Directors/Principals of SFS colleges are required to appoint the examiners strictly out of panel keeping in mind that "No reciprocal appointment should be made".


